For a Fixed Price or Fixed Price 6 Month Easy Pay/Budget Program:

- * All contracted gallons will be delivered at contracted price until all gallons have been delivered. The customer must receive delivery of all pre-purchased gallons from this contract prior to receiving gallons from any subsequent pre-paid program offered by Jack Rich Inc. or delivered at posted market price. After all pre-purchased gallons have been delivered, subsequent deliveries will be billed at Jack Rich Inc. market price on day of delivery. An inventory charge of \$5.00/month may be assessed against the customer's credit balance for any contracted gallons not delivered by September 30, 2022.
- * Delivery period begins: September 1, 2021 & delivered until purchased gallons are used!
- * **All participants must be on automatic delivery. All deliveries must be consecutive. Purchasing fuel from another supplier during the contracted delivery period will void this contract and a market assessment fee may apply.**
- * If a refund is requested for any reason, it is subject to approval by Jack Rich Inc.. A market assessment fee may apply.
- * Signature and/or payment obligates Jack Rich Inc. for delivery and obligates the customer for receipt of contracted gallons. Enrollment begins after deposit is received. Contract void if full contracted amount is not paid in full by: Aug. 15, 2021 for Fixed price program or December 15, 2021 for Fixed Price Easy Pay; deposit and installment payments will be forfeited. Additionally, a market assessment fee may apply.
- * If customer wishes to discontinue Automatic Delivery after all pre-purchased gallons have been delivered, the customer must notify Jack Rich Inc. in writing that they do not wish further automatic deliveries.
- * All over due balances must be paid prior to September 1, 2021.
- * **Minimum deposit must be made with contract application. Balance must be paid by August 15, 2021 (Fixed Price) or December 15, 2021 (Easy Pay/Budget).**
- * Budget payments due from July 2021 to December 2021. All contracted gallons will be delivered at the purchase price until all purchased gallons have been delivered.
- * Sales tax, if applicable, must be paid in advance.

For Capped Gallons:

- * Full CAP payment is due with signed contract.
- * Price protection fee serve as an insurance policy and are non-refundable. If you would like to Cap more than 1,000 gallons, please call the office.
- * Gallons capped apply to consecutive deliveries.
- * Cap deliveries will start September 1, 2021 and end May 31, 2022.
- * Accounts outstanding must be paid in full before entering the program.
- * Delivery fees apply if customer requests less than 150 gallons.
- * Previous pre-pay gallons will be delivered prior to the start of this agreement and are not covered under this year's cap.
